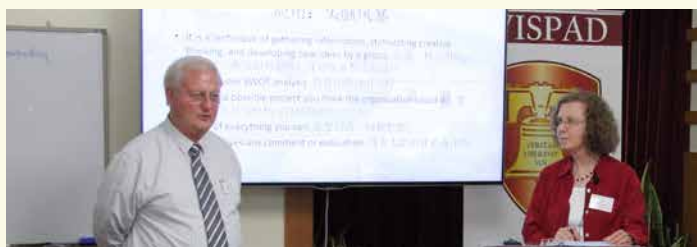

Location and Applications

- ◇ Workshops in Beijing are held in WISPAD's state-of-the-art Conference Rooms, located in the Haidian district, easily accessible from Zhichunlu subway station (Lines 10 and 13).

Format

- ◇ Workshops include 8 sessions over four full days.
- ◇ All workshops are bilingual with English-Chinese materials and live translations, except the Strategic Volunteer Management Workshop, which is in Chinese.
- ◇ WISPAD's Workshops are limited to 20 participants.
- ◇ Teams of 2 to 3 participants per organization are encouraged.



Discounts

- ◇ 10% discount of the subsidized fee for group registration of 2 or more participants from the same organization per Workshop.
- ◇ 5% discount of the subsidized fee for early registration at least one month before start of the respective Workshop.
- ◇ The discount rates can be combined.
